PROTECTION OF VULNERABLE GROUPS (SCOTLAND) ACT 2007		
The Protection of Vulnerable Groups (Scotland) Act 2007 created the PVG Scheme and places legal obligations on The Scout		
Association to check adults volunteering / offering to engage in regulated work with children against barred lists. In order to comply,		
all adults that wish to help in Scouting on a regular basis, as Leaders or Certificated Section Assistants, will be subject to an		
enhanced level criminal record check that will require membership of the PVG Scheme.		
The requirement to check casual helpers against the List is dependent on the roles and responsibilities they may offer to take on.		
Whilst an enhanced level criminal record check may not be required, we nevertheless seek your co-operation by completing the self-declaration statement below, confirming that you are not included on any List that disqualifies you from working with children.		
No offer of casual assistance can be accepted in the absence of a signed declaration.
